

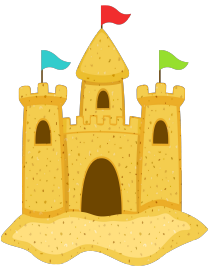

**RELEASE:** The undersigned is the parent or legal guardian of the minor camper, identified above. In consideration for Little Learners providing to the camper identified above a camp Experience at Camp Calabasas, I HEREBY, ON MY OWN BEHALF AND ON BEHALF OF THE CAMPER, RELEASE AND DISCHARGE LITTLE LEARNERS, LLC, THE OWNER AND OPERATOR OF CAMP, AND THE CITY OF CALABASAS AND BOTH OF THEIR OFFICERS, DIRECTORS, EMPLOYEES, VOLUNTEERS AND AGENTS (called herein the "Releasees") FOR AND FROM ANY AND ALL CLAIMS ARISING OUT OF THE CAMPER'S PARTICIPATION IN THE CAMP, INCLUDING CLAIMS ARISING OUT OF THE NEGLIGENCE OF THE RELEASEES OR ANY OTHER CAMPER THAT CAUSES, OR IS CLAIMED TO CAUSE, INJURY OR DEATH TO THE CAMPER IDENTIFIED ABOVE, PROPERTY DAMAGE, OR OTHER DAMAGES. **ASSUMPTION OF RISK:** I understand and acknowledge that participation in camp activities involves risk of injury. I fully appreciate the risks involved in my camper's participation in these activities and voluntarily assume, on the camper's behalf, those risks.

**PROMISE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS:** In consideration of the above camper being permitted to participate in Little Learners camp, I agree to defend, indemnify, and hold harmless the Releasees from and against all claims arising out of the camper's participation in the camp.

**EMERGENCY TREATMENT:** I hereby consent to allowing emergency medical personnel to be summoned for the camper if needed and consent to emergency treatment of the camper as may be required as the result of accidental injury or otherwise. ### Summer Camp 2025 Important Information and Admission Agreement (page 1)

**Registration:** You can bring in or email us your registration forms. **Payments are to be made out to Little Learners. There is a one time \$50.00 registration fee charged per camper.**

**Camp Times:** \*Camp Calabasas activities are scheduled from 9:00am to 4:00pm daily.

\*Extended care is offered at no extra charge from 7:30am to 9:00am and 4:00pm to 6:00pm. Parents running late will be charged \$1.00/minute after 6:00pm and it must be paid to supervising staff, for every minute that you are late.

#### **What to Bring:**

- Lunch: Campers may bring a packed lunch from home. We are unable to warm-up or refrigerate lunches. Hot lunch will be available for purchase through Bright Belly delivery service. Information will be sent in your introduction email. <https://brightbellymeals.com/>
- Water: Please bring a water bottle. There is a water station at the park to refill throughout the day.
- Sunscreen: Please apply sunscreen on your child prior to them arriving at camp. They can reapply sunscreen throughout the day if needed. **WE ARE NOT ABLE TO LEND SUNSCREEN TO CAMPERS AND THEY MAY NOT SHARE SUNSCREEN.**
- All 1st -6th graders will be shuttled over to the tennis and swim center. TK & Kinders will participate in daily water play and have use of the splash pad. Please pack bathing suits and towels daily.

#### **Camp Dress:**

- Campers are required to wear closed-toed shoes each day they attend camp.
- Shoes: Athletic style shoes, Crocs and closed toe Native style shoes are okay to be worn everyday. **Campers with open toe shoes will be sent home or must have a pair of closed toe shoes brought to them at camp.**
- Campers may only wear sandals during outside water play and while at the pool.

**Sign In/Out:** Children arriving and departing camp must be signed in and out by an adult on a daily basis.

Dropping your child off to walk into camp alone is not permitted for safety reasons. An adult must be present at drop off and pick-up.

**Custody Arrangements:** For parents who share custody, paperwork can be left on file showing the court approved agreement and we will abide by the information shown on the court document. If you have an order of protection, please make sure to provide that upon registration and it will be kept on file. We can not implement verbal orders as they will not be upheld by the local Sheriff's department if a situation were to arise.

### Important Information and Admission Agreement (page 2)

**Illness:** If your child is not feeling well during their time at camp we will take their temperature and if they are running a fever you will be called to pick them up. If we are unable to reach you those listed as emergency contacts will be called. Children will need to remain at home until they are 24 hours fever free without taking medication or after they've stopped taking other medications.

**Discipline:** We strive to provide a well-rounded and safe program for all participants. Discipline will be handled in the following manner and depending on the infraction: (1) Child will be spoken to and/or redirected to another activity (2) Child will be suspended from the program (3) A written report will be completed by the staff and a meeting will be set up with the parent to discuss an appropriate outcome. **Children causing harm to another participant or any of our camp staff may be dismissed from our program. In addition any child with three warnings will be asked to leave the program.**

**Dismissal Policy:** Expulsion from the Camp Calabasas and Little Learners Program results from one or more of the following situations: (1) Physically or verbally abusing another participant or staff member (2) Refusal to correct documented problematic behavior (3) Theft (4) Parent Payment Negligence (5) Disruption on busses, on field trips, at the pool or in general at camp (when applicable)

**Snack:** We will provide a morning and afternoon snack for all campers. Children may also bring snacks for the morning and afternoon. If your child has a food allergy or condition please make sure to mark it on the paperwork.

**Hot Lunch:** Hot lunch will be available for purchase through Bright Belly delivery service. Campers who attend the swim & tennis center may purchase lunch and snacks at the snack shack.

**Medications:** A medication consent form must be filled out by all parents/guardians in order to administer all prescribed/OTC medication. Medication must be given to us in its original packaging.

**Injury:** In case of injury, the staff shall give appropriate first aid to the child. If it is the judgment of the staff that the injury is an emergency, paramedics will be called to the site and a parent or guardian shall be contacted.

**Themes/Activity Plans:** Weekly event calendars will be available to each registrant. This will be emailed out and will be posted on our website, campcalabasas.org. These plans will show what special activities we are doing in camp as well as notifying you of any events or camp updates.

**Field Trips:** We will be offering a few field trips during Summer Camp 2025. These trips will be for set age groups and space will be limited. The cost of the field trip is in addition to the daily/weekly camp rate. Space is available on a first come basis.
